

POLICY ABOUT ENVIRONMENTAL, HEALTH AND SAFETY

As an integral part of IMB Srl development process, our management is fully engaged in pursuing a policy meant to safeguard workplace Health & Safety and the Environment.

IMB Srl, on our site of Bagnolo Cremasco as well as our Suppliers, will engage in every possible action aimed at protecting the Environment, the Health and Safety of our Employees, by preventing any possible pollution and by pursuing the continuous improvement of the HSE performances of the Company.

With reference to the HSE context of the facilities where IMB Srl carries out its own activities, the objectives in accordance with this Policy are defined as follows:

- Comply with the applicable HSE laws, whether EU, national, regional or municipal, the environmental regulations, the
 obligations imposed by the authorizations and permits issued by the authorities in charge and by all requirements
 possibly subscribed by management to prevent accidents, injuries, occupational diseases and any kind of environmental
 pollution.
- Co-operate with the local community and Authorities, our Customers, our Suppliers, and our Employees to promote a Culture of Health & Safety in the workplace and Environmental protection.
- Continuously involve Employees and their Representatives on both Health & Safety and Environmental issues.
- Raise awareness of all Employees on the importance of Health & Safety and Environmental culture in the workplace, through continuous training, at all levels.
- Management Team and the Organization are fully engaged into continuous identification of near misses, aiming to prevention.
- Continuously improve the safety and environmental features of equipment and work areas, in order to pursue the highest HSE standards
- Maintain and improve the management of HSE indicators, including the ones related to ESG (Environmental, Social and Governance to meet targets and seek for continuous improvement, in line with Corporate objectives (CHART INDUSTRIES).
- Improve the Company's energy performance by optimizing the use and consumption of utilities and services existing in the Company.
- Improve the waste collection and chemicals handling management, promoting the waste differentiation to reduce the environmental impact whenever possible.
- Redefine and optimize shop building roofs in order to improve the HSE performance management of the site.
- Optimize the management of water used for industrial purposes, in order to reduce the water withdrawal and the related environmental impact.
- Verify the compliance to the Safety norms of the utilized equipment, as part of the Preventive Maintenance program.

The General Management of IMB Srl is committed to implement-this Policy within the Company and at the Suppliers as well for consistency with IMB Srl. This can be accomplished by defining targets, periodically reviewed, and analyzed.
